



Sahara Grotto– 2022 Sportsman Raffle “Shared Sales of Proceeds” Agreement

Sahara Grotto, located in Indianapolis, IN agrees to a “shared sale of proceeds” with _____ # _____ located at _____, IN. The sale of “shared sales of proceeds” between these two Indiana organizations are for the April 23rd, 2022 Sahara Grotto Sportsman Raffle. Details of this agreement are as follows:

Terms & Conditions

- Said organization agrees to sell “books” of three 2022 Sahara Grotto Sportsman Raffle tickets, for \$50.00 per book or \$20.00 per individual ticket from a book, on behalf of the Sahara Grotto, under the Sahara Grotto’s gaming license.
- For every (250) two hundred and fifty book intervals sold by said organization, the Sahara Grotto agrees to donate to said organization or it’s sponsored charity 20% of the “shared sales proceeds” or \$2,500.00, or whichever is greater, on or before May 1st, 2022. Please note individual tickets sold will be counted in “threes” to make “books”.
- Tickets sold under or above (250) two hundred and fifty book intervals are subject to a 5% “shared sales of proceeds” interval. Example, if (270) two hundred and seventy books are submitted to the Sahara Grotto on or before April 22nd, 2022, then the 20% or \$2,500.00, or whichever is greater, for the first (250) two hundred & fifty books sold, and 5% of sales for the remaining (20) twenty books sold. To obtain the 20% or \$2,500.00, or which ever is greater, compensation to said partnering organization, or it’s charity, noted above, quantities must be sold in (250) two hundred and fifty intervals and submitted to the Sahara Grotto by said date mentioned above.
- It is the responsibility of said organization above, not the Sahara Grotto, to monitor / track all sales, collect all monies for their sales, and submit all tickets & monies to the Sahara Grotto on or before April 22nd, 2022 for those tickets to be submitted into the drawing. The tickets & monies submitted will be audited by at least one designated official from both organizations for transparency at the time of the submittal to the Sahara Grotto.
